

JK Tyre Shiksha Sarthi Scholarship Program 2026-27

The JK Tyre Shiksha Sarthi Scholarship Program 2026-27, launched under the Corporate Social Responsibility (CSR) initiative of JK Tyre & Industries Limited, is a need-based educational support program **designed to empower deserving daughters of heavy vehicle drivers through access to higher education**. The program is open to applicants residing in **Rajasthan, Madhya Pradesh, Uttarakhand, Karnataka, and Tamil Nadu**. Selected scholars will receive a scholarship of **up to INR 25,000** to support their educational expenses and help them achieve their academic and career aspirations, depending on the course being pursued. In deserving cases, the scholarship may be renewed for the entire duration of the course, subject to the student meeting the prescribed academic performance standards and renewal criteria.

Eligibility

- Open to female students who are **daughters of heavy vehicle drivers** and are enrolled in **general or professional undergraduate courses or diploma courses**.
- Applicants must have secured a minimum of **55% marks** in their previous academic year.
- Annual parental income from all sources must not exceed **INR 5,00,000**.
- Applicants must be residents of **Rajasthan, Madhya Pradesh, Uttarakhand, Karnataka or Tamil Nadu**.
- Children of employees of **JK Tyre & Industries Limited** and **Buddy4Study** are not eligible to apply.

Note: Students must complete the video interaction to become eligible for the scholarship.

Benefits

Selected students will receive the following annual fixed scholarship, depending on their course:

- **Professional Undergraduate Courses:** INR 25,000
- **General Undergraduate Courses:** INR 15,000
- **Diploma Courses:** INR 15,000

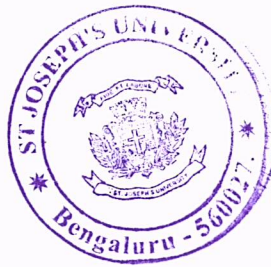
Note: Students who meet the renewal criteria will continue to receive the fixed scholarship amount each year for the duration of their course.

Documents

- Recent passport-sized photograph
- Current admission proof (admission letter or institution identity card)
- Previous year mark sheet
- Payment receipts for educational expenses (tuition fees, hostel fees, books, etc.), along with the fee structure for the academic year
- Bonafide letter from the college stating the total fees or expenses incurred by the applicant in the academic year
- Class 10 and Class 12 mark sheets
- Proof of family income (ITR, salary slips, or an income letter from a government authority such as the Gram Panchayat, Ward Councillor, Sarpanch, SDM, DM, CO or Tehsildar)
- Proof of identity (PAN card, Masked Aadhaar card, driving licence, etc.)
- Bank passbook
- Proof of the parent's profession (any one of the following):
 - Commercial driving licence of the parent (only in case of drivers)
 - Shramik card

- **How can you apply?**
- Log in to Buddy4Study using your registered ID to access the ‘**Application form page**’.
 - If you’re not registered, sign up on Buddy4Study using your Email, Mobile, or Google account.
- You will be redirected to the “**JK Tyre Shiksha Sarthi Scholarship Program 2026-27**” application form page.
- Click the ‘**Start Application**’ button to begin the application process.
- Fill in the required details in the online application form.
- Upload the relevant documents.
- Accept the ‘**Terms and Conditions**’ and click ‘**Preview**’.
- If all the details are correct in the preview, click the ‘**Submit**’ button to complete your application.
