St Joseph's University invites applications for the St Joseph's University Scholarship (Academic Year 2026–2027) to support eligible undergraduate and postgraduate students through financial assistance and academic recognition. Student are asked to apply for the scholarship according to the year they belong and scholarship category they are eligible for.

All 1st year UG& PG students.

Economic Assistance Scholarship

Eligibility:

1. Family annual income up to 3 lakhs.
2. The candidate must not have any record of disciplinary action against him/her by the disciplinary committees of the University.
3. Minimum 75% attendance in the current semester of the current degree programme
4. Income certificate (Issued by concerned state or central Govt.) or Salary certificate of the parent from employer.

All 2nd year UG & PG Students.

Academic Excellence Scholarship

Eligibility:

1. 70% and above marks in the previous semester.
2. Family income per annum less than 3 lakhs
3. Minimum 75% attendance in the current semester of the current degree programme.
4. No arrear paper in the previous semester of the current programme
5. The candidate must not have any record of disciplinary action against him/her by the disciplinary committees of the University.

Note: (All eligibility conditions are must for applying the academic excellence scholarship).



All 3rd year UG students.

Eligibility:

Academic Excellence Scholarship

1. 70% and above marks in the previous semester.
2. Family income per annum less than 3 lakhs
3. Minimum 75% attendance in the current semester of the current degree programme.
4. No arrear paper(s) in the previous semester of the current programme
5. The candidate must not have any record of disciplinary action against him/her by the disciplinary committees of the University.

Economic Assistance Scholarship

1. Minimum 75% attendance in the current semester of the current degree programme.
2. Family income per annum less than 3 lakhs.
3. No arrear paper in the previous semester of the current programme.
4. The candidate must not have any record of disciplinary action against him/her by the disciplinary committees of the University.

Note: (All eligibility conditions are must for applying the academic excellence and economic assistance scholarship)

Visit the university website www.sju.edu.in and under student login, the online application will be visible to apply for the St Josephs' University Scholarship from Tuesday, **01 September 2026** onwards.

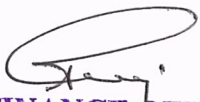

The last date to fill and submit this form online is **Wednesday, 30 September 2026**.
